



RELEASE AND WAIVER OF LIABILITY

In consideration of admission of the minor child identified below (the "Minor Child") into the Pedal to the Medal Pedal Car Race to be held on June 4, 2016 at The National Museum of Toys and Miniatures (the "Museum") and its surrounding property located at 5235 Oak Street, Kansas City, Missouri 64112 (the "Race"), I, the undersigned adult parent or legal guardian of the Minor Child, hereby releases, waives, discharges, indemnifies and covenants not to sue the Museum, The Curators of the University of Missouri (the "University"), and their respective owners, members, curators, trustees, officers, directors, officials, employees, agents and volunteers, from all liability to the Minor Child or the undersigned, their personal representatives, assigns, heirs or next of kin for any and all loss or damage, and any claims or demands thereof on account of injury to the Minor Child or the undersigned or their property or resulting in the death of the Minor Child or the undersigned, whether caused in whole or in part by the negligence of any party released herein, while the Minor Child or the undersigned is at the Race area or within its surrounding property.

The undersigned hereby assumes full responsibility for and risk of bodily injury, property damage or death of or to the Minor Child or the undersigned due to the negligence of any party released herein while the Minor Child or the undersigned is within the Race area or surrounding property.

The undersigned further expressly agrees that (i) the foregoing release, waiver and indemnity shall be governed by and construed in accordance with Missouri law, (ii) is intended to be as broad and inclusive as permitted by Missouri laws, and (iii) if any portion hereof is held invalid, the balance shall continue in full legal force and effect.

The Museum reserves the right to revoke, restrict or place limitations on the Minor Child's or the undersigned's authorization to enter or remain in the Race or its surrounding property.

I hereby irrevocably and perpetually grant to the Museum and the University a worldwide license to use, publish, reproduce, create derivative works of, distribute and publicly display the name, voice and any images or likenesses taken or captured of the Minor Child and/or the undersigned while participating in Race (collectively, the "Name and Images"), in any form, media or content which now or hereafter exists, for advertising, promotional or any other commercial purposes as well as non-commercial purposes, and I hereby waive any compensation for any use of such Name and Images. I hereby release the Museum and the University and hereby waive any claims, demands, damages, losses, liabilities and causes of action arising from the conducting of any of the above authorized uses of the Minor Child's and/or undersigned's Name and Images, including, without limitation, any claims for defamation, libel, invasion of privacy, publicity, personality, or exploitation of name or likeness.
